Evolution of Investigation and Revelation of the Extraterrestrial Matter

I have explored the UFO-UAP/Extraterrestrial phenomenon periodically since the later 1960s. Initially there were many isolated reports with mainly local observers and investigators. During this time, the government was especially fond of balloons as the explanation for UFOs, and the extraterrestrial theme got picked up and exploited by the entertainment and science fiction “industry.” The combination of fictional exploitation and systematic government dismissal and ridicule of UFO reported events instilled the view in the public that the extraterrestrial issue was a little more than a fantasy and not worthy of serious consideration. Still the reported UFO sightings and contact events persisted and investigative specialists emerged with more detailed accounts and suggestions of systematic government obfuscation. Slowly, local investigators coalesced into groups, and over time these groups grew in size to eventually become transnational organizations like MUFON [Mutual UFO Network]. Eventually, investigators began penetrating the intelligence agencies and getting some highly suggestive insider information on the participation of major corporations of the military industrial complex in analyzing UFO crash debris in behalf of reverse engineering the technology. All of this was intended to be kept tightly secret as orchestrated by MJ-12, the federal level secretive administrative organization with tight fingers in all of the government’s intelligence agencies and departments as well as the military industrial complex.

With the turn of the new millennium, a few intelligence insiders began to offer information on 1) the extent of the government’s black project commitment to the investigation of extraterrestrial matters, 2) the government’s vast intelligence commitment to secrecy, and 3) the existence of considerable research on extraterrestrial biologics, mainly from autopsies of crash site bodies. Finally in the modern era, and especially in the 2020s, intelligence officers who have spent careers investigating and administering within government UFO-UAP projects and programs began cautiously to speak out – ultimately revealing agreements having been reached between alien humanoids living on Earth and our government. These long-time, highly knowledgeable, insider whistleblowers provided information that was accompanied by much greater credibility. In this context, the need for disclosure received a huge boost, a disclosure movement arose with considerable public support, and eventually Congress committed to seriously investigating the alien issue. To date, Congress has only opened the door, and the secrecy forces within government remain in place with strong

influence including an ongoing disinformation campaign. We remain betwixt and between but with a much greater opportunity for full revelation.

Broadly speaking, this is the evolution of the treatment of the UFO-UAP/Extraterrestrial issue that I have observed over the years.
